# BEVERLEY SCHOOL'S BURSARY POLICY

## Context

Educational bursary funds are available to post-16 institutions to support disadvantaged learners beginning and / or continuing post-16 study. Funding is awarded to meet individual needs, for example, to help with the cost of transport, meals, books and equipment.

## Policy for Financial Support 2022/23

### 1. Support for Vulnerable Learners

If a student is in one of the nationally nominated vulnerable groups they are guaranteed a £1,200 bursary. The following groups of students are eligible:-

- Young people in care or care leavers
- Young people (not their parents/carers) in receipt of Income Support
- Young people (not their parents/carers) in receipt of Universal Credit
- Disabled young people in receipt of Employment and Support Allowance who are also in receipt of Disability Living Allowance or Personal Independence Payments.

These payments will be made at the end of every term, following deductions for expenses incurred during the term. Deductions may include payments for the following:-

- Costs of curriculum educational visits, e.g. visits to museums, art gallery, etc.
- Payment for any residential
- Any other educational costs incurred to which we will give you prior notification

Payments will be made, if necessary, into a student's bank account on the following dates:-

- Friday, 22<sup>nd</sup> December 2023
- Friday, 22<sup>nd</sup> March 2024
- Friday, 19<sup>th</sup> July 2024

## 2. Discretionary Bursaries

If household income is less than £16,190 or you are in exceptional short-term financial need, you are eligible to apply for financial help from the College's Discretionary Support Fund. This is limited and any offer of help will be subject to the availability of funds.

As per government guidance (and different to previous years), no cash payments will be made as funds will be retained in school to pay for the following:-

- Costs of curriculum educational visits, e.g. visits to museums, art gallery, etc.
- Costs of food/meals
- Payment for any residential
- Additional amounts required for equipment and resources
- Taxis paid for by school to take students home from afterschool clubs

If an application is accepted on the grounds of exceptional short-term need, support needs will be discussed with each student on an individual basis. These payments will be to a maximum of £200 and are subject to the agreement of the Headteacher.
